MEMBERSHIP CATEGORIES AND SUBSCRIPTION RATES

Full Membership

The annual subscription is 1.1 percent (inclusive of GST) of your annual salary or wage as prescribed in your Enterprise Agreement or other arrangement that applies to you as at 1st January 2011.

The annual subscription for members who are employed on a **casual basis** in either the Seagoing or Offshore Oil and Gas Industry is **the greater of**

- (1) 1.1 percent of the gross amount of earnings as shown on your Payment Summary issued for the period ended 30th June 2010 (incl. GST)
- or**
- (2) \$575.00 (incl. GST) if your annual salary is less than \$52,000.00.

For members looking for work in the industry the annual subscription is \$290.00 (incl. GST).

Deferred Membership

A financial member who ceases to be employed in the Australian Shipping and Marine Industry can make an application to defer his/her membership of the AMOU for the period of his/her absence from the Industry. The annual subscription for Deferred membership is \$115.00 (incl. GST).

Associate Membership

Associate Membership is available to Members who have retired or have been forced to retire permanently due to ill health or accident. No fee applies for Associate Membership.
